



ANIMAL REGISTRATION APPLICATION

In accordance with City Council Ordinance 83-18, Section IV.E-201, every dog, four (4) months of age or older, is required to be registered with the City of Irvine. New residents, or residents with newly acquired dogs, shall be granted thirty (30) days in which to comply with this section. Persons renewing pet registration shall be granted thirty (30) days from the date on which they are due to comply with this section. Failure to comply will result in a late fee as determined by City resolution.

A minimum of one year registration is required. Two- and three-year licenses are also available. A pet's registration is valid only as long as the pet's rabies vaccination is valid. If the registered pet's rabies certificate information does not cover the full length of the registration period, it is the pet owner's responsibility to supply current rabies vaccination information to the Irvine Animal Care Center either by mail, fax, or in person. A reminder notice will be included with your animal registration if an updated rabies certificate will be required during your registration period (copies are accepted).

Permanently disabled citizens or senior citizens 62 years of age or older may register their dogs at a reduced rate (proof of age or disability required).

NOTE: Pet Registrations are not transferable or refundable.

Please provide a work and/or emergency phone number in addition to a home number. This information will assist our staff with the safe return of your pet if it should become lost or injured.

Attach a current rabies certificate and a sterilization certificate if your animal has been altered. These certificates will be returned along with your new registration certificate and registration tag (copies are accepted).

Checks or money orders must be payable to the **CITY OF IRVINE**. Credit cards will be accepted by mail and in person. Cash will be accepted with a completed application in person only.

Please complete the application on the following page and return it with a copy of your pet's rabies certificate (required), proof of sterilization (optional), and proof of age or disability (optional).
