After submitting my Q4 lobbying report, I thought I might provide just one more bit of clarification for Section 3 sub 2. As listed, I met with Building Department officials, at their request, to learn more about their field inspection and plan check processes. Although Deputy Director Cardoza was invited, the meeting was with Supervisor level staff and as such, I don't believe it triggers the lobby ordinance under the terms from the lobbying guide as follows:

Who is a City official under the Lobbying Ordinance?

City official means the Mayor, the Vice Mayor, the Interim Mayor, members of the City Council, City Council Executive Assistants, the City Manager, Assistant City Managers, Department Directors, the Police Chief, the City Attorney, the City Clerk, the Zoning Administrator, members of the Planning Commission, members of the Community Services Commission, members of the Finance Commission, members of the Sustainability Commission, members of the Transportation Commission, members of any other commission that is advisory in nature, members of any committee, designees of any of the above listed individuals, and any person with authority to decide, any non-ministerial legislative, executive, or administrative action on behalf of the City or any agency on which the City has a seat.

For further reference and clarification, the meeting was scheduled by Lucy Prado of the Community Development Department on 11/7/24 and should be included in the city's record. I am happy to provide additional detail if necessary but I do not believe this meeting meets the threshold of needing to be disclosed. I included this meeting in my report in the interest of providing as much transparency as possible but happy to amend if this interpretation is incorrect.


